ALL OF OUR MARKETS ACCEPT ELECTRONIC BENEFIT TRANSFER (EBT, FORMERLY CALLED FOOD STAMPS) CARDS, AS WELL AS WOMEN INFANTS & CHILDREN (WIC) CHECKS.
